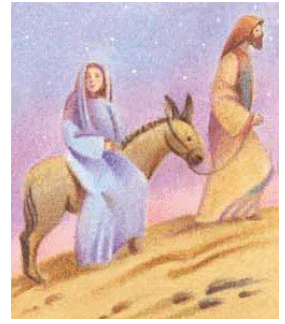

The Nativity Story ...

How Much Do You Know About Abortion?

While searching websites looking for information for this month's article, I found these statistics about abortion. I decided to share them with you so you will be better informed about abortion in the United States and its affect on our society. There is one other interesting thing to note: the Alan Guttmacher Institute is Planned Parenthood's research affiliate, and Planned Parenthood is the largest abortion provider in the U.S. That makes the information below even more interesting.

Also note that rape and incest account for only 1% of abortions, yet that is the most frequently cited reason for abortion by pro-choice groups because they know that strikes a chord with most women.

Quick Facts About Abortion:

- 70% of women getting abortions are unmarried. (Source: USA Today, Jan. 22, 1998)
- Abortion is the most frequently performed surgical procedure in the United States. (Source: Alan Guttmacher Institute)
- Studies show that there is a 150% increase in rates of breast cancer for girls under 18 who abort at 8 weeks gestation or greater. (Source: British Journal of Cancer, 1981)
- In America, 165,000 babies are aborted in the second and third trimester. (Source: Center for Disease Control Statistics)
- According to a 1999 USA Today/CNN/Gallup poll, 71% of Americans favor some or total restrictions on abortions.
- Social or "birth control" reasons account for approximately 93% of all abortions. So-called "hard cases" of rape, incest, health of baby, and threat to life or health of mother account for less than 7%. (Source: Family Planning Perspectives, July/August 1988)
- 57% of Americans believe abortion is murder. (Source: LA Times Poll, 2000)
- Nearly two-thirds believe abortion should be illegal after the first trimester. (Source: LA Times Poll, 2000)
- Currently, abortion is legal for any reason in every state of the union.

Women Who Have Had Abortions Cite the Following Reasons:

- 21% can't afford a baby
- 21% are unready for responsibility
- 16% concerned about how having a baby could change their lives
- 12% have problems with relationship or want to avoid single parenthood
- 11% are not mature enough/are too young to have children
- 8% have all the children they want/have all grown-up children
- 3% possible fetal health problem
- 3% maternal health problem
- 1% pregnancy resulted from rape or incest
- 1% husband/partner wants them to have abortion
- 1% don't want others to know they had sex or are pregnant

Roe is Not Only About Abortion. It has Often Been Cited by Judges to Endanger Human Beings Already Born:

myth: Roe v. Wade is only about a woman's right to abortion, not about a right to take life in general.

fact: Roe has often been cited by state and federal judges to endanger human beings already born.

- In 1986, relying on Roe, the Supreme Court invalidated a law intended to ensure care for children born alive during attempted abortions.¹
 - In 1983, a U.S. district court invalidated a federal regulation to prevent medical neglect of handicapped newborns in hospitals receiving federal funds. The court said the regulation may "infringe upon the interests outlined in cases such as ... Roe v. Wade."²
 - In 1980, a New York court cited Roe in a "right to die" case, arguing that the "claim to personhood" of a terminally ill comatose patient "is certainly no greater than that of the fetus."³
 - In 1993, a Michigan judge cited Roe in dismissing criminal charges against Jack Kevorkian and declaring that the state law against assisted suicide was unconstitutional.⁴
 - And in 1996, the U.S. Court of Appeals for the Ninth Circuit relied heavily on Roe and its successor, Planned Parenthood v. Casey, in finding a constitutional "right" to assisted suicide.⁵
 - While some of these rulings were later modified or reversed, they all underscore how Roe v. Wade has been used to argue that ideas of privacy and liberty can life itself - after as well as before birth.
