Keep on selling! We were allotted 1500 tickets total.

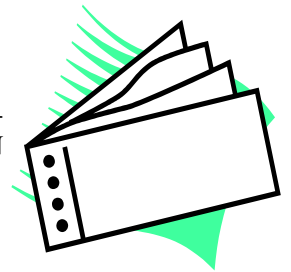

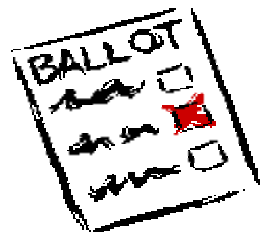

Business Meeting Minutes

Business Meeting Minutes for April 12th, 2006

The Meeting officially opened at 7:37.

Prior to the opening of the meeting, a presentation of a check for \$1,552.36 was made to Tony Fortcamp of Fairfield Industries as part of last year's Measure Up Campaign. Fairfield Industries is an adult program for the mentally retarded and those with disabilities. About ½ of the participants in the program participate in supported work contracts where each participant works at their own level. The other ½ are in self help and independent living skills. Fairfield Industries has recently moved to Coonpath Rd & 33, there they have 1 floor of air conditioned classrooms recently renovated. They plan to use the money to purchase sensory stimulation devices to assist the autistic in focusing. They will have several rooms dedicated to assisting. Their Blue Shoe art program continues and may be moved to Pickerington.

The meeting re-opened at 7:53 P.M

Reading of the Minutes: A motion was made to dispense with the reading of the minutes and accept them as published. The motion was seconded, and approved by the council.

Chaplain's Report: No Report

Admissions: No Report

Heinzerling Foundation Special presentation: Michele Treitmaier made the presentation. The Heinzerling Foundation is a residential facility. The facility has a 21 million dollar budget supported by Medicaid and fundraising.

All residents are non-verbal non-ambulatory. The fundraising portion of their budget allows them to purchase form-fitted chairs and therapy equipment not covered by Medicaid. There are currently 550 employees and 1 faculty member for each child. They are now raising money to purchase special communication devices to assist the residents in communication. These devices allow the residents to communicate with simple head or other body motions. Each resident is under 24 hour care 7 days a week.

The facility is 50 acres located off of Frank Rd, and has been there since 1959. When asked about admittance procedures Michele let us know that they have a group of professionals that screen applicants for admittance, most need admitted. Sometimes the facility has a waiting list some times it does not. Michele also explained that 2/3 of the residents are permanent and will spend their whole lives there. There is no parental cost involved at the facility; in fact it was noted that 2/3 of the parents live out of state or are unable to cope with the demands of their children so are rarely if at all able to visit.

Grand Knights: There will be no first Sat. Mass in May or officers meeting due to brother Hectors Ordination. The Grand Knight offered his thanks to Ron Schubert the program director for getting full credit on 3 activities since the last meeting. Gene Ebert provided attendance information for 2002-2006 which showed we had an average meeting attendance of 27 members.

Tonight we were blessed with 39 members. We need to commit to getting more Knights involved in the business meetings.

Bog Glavan and Joe Drignat have been working on inactive members and getting information. Some have paid their back dues, some are interested but still not able to actively participate, and others are no longer interested. They have prepared and executed 37 notices to suspend.

The Family of the Year dinner has been rescheduled to Mothers day, currently no one from our council can attend. If anyone is interested please let the Grand Knight know.

The State Convention will be on the 26, 27, and 28th which is Memorial Day weekend. George Williams is considering going, other Knights are committed to a wedding in Nags Head. Any third degree Knight is eligible to attend and planned activities include a golf tournament and other events.

Currently we are at 121% of our membership goal, but this will change once we have submitted the notices to suspend previously discussed. April 17th is the first turn in for the Raffle tickets. Bud Joos already had \$1,758 from the sale of 345 tickets already. We received 1,500 tickets and have distributed all but 50.

The Coach and two members of the Fisher Catholic baseball team came in to thank us for our donation and show us the banner that would be placed in the outfield. They also presented us with a signed baseball.

Neil Ferguson stated that he had received a thank you from the Grand Knight at his old council for the gift certificate we had sent him in thanks for all the wonderful help he has provided us in getting our coffee makers and parts at such great prices.

Last it was announced that the new slate of officer candidates was now out. The election will be at the June meeting.

We received a thank you from the Dance academy from St. Pats.

John Bitler from Easter Seals sent thanks for the donation.

Chris Schubert and Jacob Brewer sent thanks for the donation to the MDA Association.

Treasurers Report:

Currently we have no outstanding bills. A question was asked about the Christmas Eve parking and it was stated that we had went ahead and paid the \$XXX requested even though it exceeded the agreed upon amount due the extra services they provided.
