A letter was received from Nancy Putnam, a lieutenant Colonel in then US Army, and is the deputy Civil, Military operations officer. She thanked us on behalf of the Iraqi people, and American soldiers in Iraq. With our kind assistance they are able to provide assistance to the local population.

**Trustees Report:** The Budget was distributed to all present for approval. This is the 5<sup>th</sup> revision. Expenses have been budgeted at \$XXXXX. Income is \$XXXXX. ## Roe Reality Check

January 22, 2007, is the 34<sup>th</sup> anniversary of *Roe v. Wade*, the Supreme Court decision that legalized abortion in the United States. I thought this would be a good time to check out the US Conference of Catholic Bishops (UCCB) Secretariat for Pro-Life Activities "Roe Reality Checks":

- 1. Myth: High court rules abortion legal in the first 3 months Fact: Abortion is legal through all 9 months of pregnancy for any reason.** *Roe* allows abortion "to preserve the mother's health". Companion decision *Doe v. Bolton* defined mothers health, particularly mental health, so broadly that there is absolutely no restriction on abortion.
- 2. Myth: Most abortions are done because of maternal or fetal health problems, or in cases of rape or incest. Fact: Abortions are rarely done for these reasons.** Only a very small percentage are done for these reasons: 1% rape or incest 3% woman has health problem (physical or mental)| 3% fetus has possible health problem. The remaining 93% are done for the convenience of the mother.
- 3. Myth: Most Americans favor U.S. abortion law. Fact: Most Americans actually oppose it.** 61% say abortion should not be permitted after fetal heartbeat has begun (usually around 21-22 days after conception). 72% say abortion should be illegal in the 2<sup>nd</sup> three months of pregnancy. 86% say abortion should be illegal in the last three months of pregnancy.
- 4. Roe said the Constitution includes a right to abortion. Even legal commentators who support legal abortion have said Roe is not good constitutional law.** Supreme Court justices and legal experts have often criticized *Roe v. Wade* as a bad decision because it is not constitutional law and doesn't even try to be.
- 5. Myth: Most American women support Roe v. Wade. Fact: Most do not.** Only 30% think abortion should be generally available. 17% say abortion should never be permitted. 34% say abortion should only be permitted in cases of rape, incest, or to save the life of the mother.
- 6. Myth: U.S. abortion law has not encouraged the use of abortion as a method of birth control. Fact: Nearly half of all abortions are performed on women who have already had at least one.** 48% of women having an abortion in the United States have had at least one previous abortion.
- 7. Myth: Roe v. Wade is only about a woman's right to abortion, not about a right to take life in general. Fact: Roe has often been cited by state and federal judges to endanger human beings already born.** In 1980, a New York court cited *Roe* in a "right to die" case, arguing that the "claim to personhood" of a terminally ill comatose patient "is certainly no greater than that of the fetus." In 1993, a Michigan judge cited *Roe* in dismissing criminal charges against Jack Kevorkian and declaring that the state law against assisted suicide was unconstitutional. And in 1996, the U.S. Court of Appeals for the Ninth Circuit relied heavily on *Roe* and its successor, *Planned Parenthood v. Casey*, in finding a constitutional "right" to assisted suicide.
- 8. Myth: Abortion is standard medical practice; only religious hospitals and some physicians refuse to provide it. Fact: Even abortion advocates acknowledge that abortion is outside mainstream medicine.** The vast majority (86%) of all U.S. hospitals whether religious or secular, public or private, do not participate in abortions. 71% of abortions in the United States are performed in free-standing abortion dedicated clinics. Only 5% are performed in hospitals, 2% in physicians' offices and 22% in other kinds of clinics. A New York Times Magazine article reports, "The overwhelming majority of abortions are performed by a small group of doctors. (Some 2 percent of OBGYN's carry the burden)."

Knowledge is power – use these facts to clear up misconceptions your friends and family have about abortion. When enough people realize what the Supreme Court has wrought, we can force them to change the law.

In the meantime, support Right to Life initiatives here at Seton parish. On the weekend before the *Roe v. Wade* anniversary (January 22), there will be a Mass for Life. Check the bulletin for exact time and be sure to attend in force. Wear your Knights shirts to show your support!
