Farewell, Papa

When Pope Benedict XVI visited the United States recently, he covered a lot of ground. He reinforced his support of human rights and respect life issues, spoke about the sex abuse scandal, celebrated his 81st birthday, met with President Bush, celebrated Masses with thousands of people, prayed at Ground Zero and impressed even non-Catholic Americans.

In his meeting with President Bush, the Pope discussed terrorism and how to confront it while respecting human rights. They also expressed concern about protecting human life, marriage, and family values. Both leaders totally rejected terrorism and the use of religion to justify immoral and violent acts against innocents according to a statement released after a private meeting. They further touched on the need to confront terrorism with appropriate means that respect the human person and his or her rights. President Bush told the Pope: "In a world where some evoke the name of God to justify acts of terror and murder and hate, we need your message that God is love."

The Pope said that religious values helped forge the soul of the nation and urged Americans use these values as inspiration as we deal with complex political and ethical issues. He said he has "great respect for this vast pluralistic society." Speaking about freedom in the U.S., the Pope stated that Americans have always understood freedom as not just a gift but as a summons to responsibility. "It also demands the courage to engage in civic life and to bring one's deepest beliefs and values to reasoned public debate," he said. The Pope went on to say: "Democracy can only flourish, as your Founding Fathers realized, when political leaders and those whom they represent are guided by truth and bring the wisdom born of firm moral principle to decisions affecting the life and future of the nation."

President Bush drew applause when he said: "In a world where some treat life as something to be debased and discarded, we need your message that all human life is sacred and that each of us is willed and each of us is loved and each of us is necessary."

The most somber event of the Pope's six day visit occurred when he left the crowds far behind and knelt in silent prayer at Ground Zero. He blessed the ground where the World Trade Center stood and met with a group

of survivors and victims of the 911 attacks.

In addition to his strong support of respect life issues, what was most impressive about the Pope's visit was the vast outpouring of support for him. In Masses attended by huge numbers of people, especially youth, you could see the awe and reverence American Catholics have for this man. Equally impressive were the non-Catholics that came out to honor and respect him. He met with other Christian leaders and spoke at a synagogue to express his respect for the Jewish community. Many of these people said how powerful the experience of meeting the Pope was. Even the secular mainstream media was impressed by this love and gentleness of this great man.

Business Meeting Minutes

April 9, 2008

Meeting opened at: 7:38

Roll of Officers: All Officers were present, 3 year trustee vacant

Scholarship Presentation: The Scholarship was presented to James Hare by Gene Ebert. James told the council he was currently looking at going into engineering. His mother and father were also present at the presentation.

Reading of the Minutes: A motion was made to approve the minutes as corrected. This motion was seconded and passed.

Chaplain's Report: No Report

Admissions: No Report

Grand Knights: The Grand Knight informed the council that we were done with our fund raising and our next 2 projects were the Blue Coats dinner next Friday and the Ordination party in May. The Grand Knight has not yet had his follow up meeting with Father Klima so he had nothing to report on that end. The Grand Knight then reminded everyone that elections were upcoming and the fraternal year was winding down.

Communications: The Grand Knight has received a lot of out-of-state requests for donations. He has been putting these aside for now.

Treasurers Report:

The Treasurer reported that there are two additional checks to be deposited in the magnets account totaling about \$XXXX

Fish Fry profit /loss

The expense budget was \$XXXX so the expenses were under budget.

For St Patrick's Day we had

The expenses exceeded the approved expenses of \$XXXX. A motion was made to approve the \$XXXX that exceeded the budget. The motion was seconded and the floor was opened for discussion. The expenses were broken down \$XXXX on beverages, \$XXXX on decorations, \$XXXX on entertainment, and \$XXXX on

food. The motion was called for vote and it passed.

Bills: The bills were read. A motion was made to forward the bills to the trustee for approval. The motion was seconded and passed.

Financial Secretaries Report: The Financial secretary informed the council that he has only 15 members that are behind on their dues payment. The Grand Knight will sign letters of intent to suspend and they will be sent out. The Financial Secretary will usually get a reply from the letters once received. We collected \$XXXX since January and almost \$XXXX for Gimme Five which is almost double last year's collection. A motion was made to forward the bills to the trustee for approval. The motion was seconded and passed. It was suggested that we breakdown the membership we do lose if any into avoidable or unavoidable. Most are of the unavoidable because they have moved and we cannot locate them.

Trustees Report: No Report, although the trustees offered their compliments to the Financial Secretary and Treasurer for the wonderful jobs they have done so far this year.

Chancellors Report: The Chancellor presented the Mass travel kit we have purchased for Fr. Dave Schalk. The bottom of the goblet will be engraved with our council number and will be made for the outside of the kit. On Sunday April 13th from 3-5 there will be a learning the Rosary class, including a short history of the Rosary. Cookies and snacks will be provided. We will have another living Rosary in October. May 25th is Dave Schalk will perform his first Mass here at Seton and we will have the picnic afterward. Lots of help will be needed and a 4th Degree Honor Guard will be requested as well.

Advocates Report: The Advocate reminded everyone that Political neutrality is needed on discussions during election years.

Service Committees:

Membership: No report. We did bring in 3 new members two weeks ago.

Program Director: The Director asked for more participation in the "Of the Year" awards more nominations would be appreciated next year. There is also a family of the month award that can be submitted

to Supreme. All programs are up to date.

Church Director: No Report

Youth/Squires: The Squires have accepted the obligation of cleaning the statue 2x a year once it is in place. There is a Squire corn hole tournament on May 17th but there are a lot of conflicts so they may not be able to attend. The have volunteered to work the Picnic for Father Schalk. The Squires have inquired about holding a dodge ball tournament for Squires here at Seton and have asked us to verify that insurance coverage is available. The insurance agency will be inquired to determine the cost. If they can make this an overnight event they have asked the Council to assist them in hosting the event and provided food if needed. January 31st is the target date but is still subject to change. A motion was made to assist the Squires subject to approval of the event on all fronts. The motion was seconded and passed.

Respect Life Committee: Edd found that a bus will hold 54 people. Based on 48 people it will cost about \$200.00/person for a 1 night trip of \$328/person for a 2 night trip. If we can get 54 the cost would drop to \$184/person for the 1 day trip or \$314/person for the 2 day trip. The 2 night trip seems to be preferred. This trip would include a Mass and trip to the Basilica. The Respect Life group will attend the 7:00am Mass at St Patrick's on April 19th and then stand in front of an abortion mill. It is a very moving experience. We will stand on the sidewalk and pray the Rosary. They will meet at Seton and car pool over. On May 17th at 9 am, they will fill cups with flowers and deliver them to the nursing homes. On Wed. May 29th at 6:30 pm in Herman Hall she will need help packing up donations to the military.

Blue Coats: April 18th is the date. Please attend if you can. Clean up help may be needed.

Blood Mobile: The 1st Blood Mobile will be on May 28th on a Wed. We will need volunteers to assist in manning it.

Charity Tickets: \$XXXX was turned in tonight as part of the first turn-in. Distributed about 1,500 tickets but the computer has crashed. The 2nd turn in is May the 16th. the big break is 4/member but we have yet to hit 3/tickets per member.

Kroger Cares Program: We had charges of \$XXXX. We received a check for XXXX.

Measure Up: - We have 9 volunteers so far. We still need volunteers the times will be posted in the newsletter. We would like to completely fill all the time slots and collect after the Mass's on that Sunday.

Unfinished Business:

Donation to squires of pancake breakfast money: the Scribe reread the motion from June 13th of last year the motion did specify that we would donate the proceeds from 1 pancake breakfast to the squires for fraternal year 2007/08. There was some discussion as to weather this donation had already been made or not. We did not have the check book records available at the meeting.

Jesus Statue Motion: We have a motion on the floor to spend up to \$XXXX on the replacement of the Blessed Jesus statue in the front of the church. This will be for the Statue, shipping, mounting and a dedication plaque. The motion was published in the newsletter. There was no discussion and the vote was called and passed.

New Business:

Chapter discussion: Fran informed the council that the Council leadership had withdrawn from the Columbus Chapter and would not be paying their Chapter dues. Fran informed the Council that we are a member of the Columbus Chapter weather we want to be or not due to how the chapter is formed. The Council membership has the option to decide weather of not to pay our Chapter dues of \$XXXX a year. Fran informed the Council of some of the chapter programs such as Family Rosary day, TV Mass, VA assistance, Keep Christ In Christmas billboards, Right to Life march, Knight and Family of the year, Clipper ticket sales, and the Clergy Appreciation dinner. He then encouraged the entertainment of a motion to approve the dues.

The Grand Knight responded by noting that he had sent

2 letters to the president of the Chapter asking a representative to attend an officers meeting to supply information about the Chapter. He has received no response to either letter. The Grand Knight wished to avoid laundering unresolved issues at the Council meeting.

A Trustee suggested we discuss the perceived fiduciary problems of the Chapter at our next officers meeting. The Financial Secretary repeated that the officers have asked the Chapter repeatedly to have a representative attend the officers meeting in an effort to resolve questions of fiscal reporting and/or record keeping that have concerned the officers. This would allow the questions to be resolved without causing confusion among those not familiar with the issues. He then stated that it is not required for any Council to belong to the Chapter.

Additional discussion was made about the income and expenses of Rosary day, but the Chapter documents were not available to have a reasonable discussion during the meeting. The main issue of concern was record keeping within the Chapter. Fran informed us that the State Deputy had informed them that the Chapter did not have to come to answer the questions.

Pennies For Heaven: It was noted that our Pennies for Heaven was light at \$XXXX. He proposed adding additions funds to make to total an even \$XXXX. It was mentioned that donations always come from the same group of donors. A suggestion was made to collect after Church for Pennies for Heaven. The motion was made for the council to donate \$XXXX to Pennies for Heaven so that our total donation this month would be \$XXXX. The motion was seconded. The floor was opened for discussion. It was noted that we should look for alternatives to passing the bottle around. Fran noted that the state has asked Council' to come up with other ways to raise money for vocations. Last year he had asked Father Klima about collecting after Church and the idea was rejected. The motion was called and passed.

Convention Ad: A motion was made to purchase a full page ad in the convention book at the cost of \$XXXX. the motion was seconded and passed.

Convention Delegates: It was noted that the Grand

Knight and Deputy Grand Knight were delegates by default and if they were not able to attend alternate delegates could be appointed. This appointment was set to be discussed at the officers meeting.

RSVP Program: It was noted that our two previous RSVP programs were completing their schooling and transferring to another parish. It was noted that we can select candidates anywhere. The cost is \$XXX/candidate and we are refunded \$XXX/candidate. It is also expected that the council would provided encouragement as well. A motion was made and seconded to suspend the program for this year since we do not have readily known candidates. It was noted that we had till June 30th. It was also noted that we are already contributing to seminarians in different ways including the kit and party. The motion was called to vote. The vote was split. A hand count passed the motion. So we will not participate in RSVP this year.

Child and Family Services Donation: A member that had recently had a child a Children's Hospital with Pneumonia. His son has recovered and although the Hospital itself was not real helpful. The non profit Child and Family services organization help tremendously. This organization helped keep his son and family comfortable as well as others at the hospital. A motion was made to donate \$XXXX to the Child and Family services organization at children's hospital. The motion was seconded, called to vote and passed. It was noted that we need to have some kind of budget to split out our donations so that we can focus our donation on what we truly want to do as a council.

Elections: We are due for elections and assistance in forming our budget. The trustee will inquire about current officers running for re-election and they will post all positions in the newsletter. Anyone wishing to nominate someone should notify the trustees.



Father Schalk' vestments: It was noted that the vestments for Fr. Schalk cost \$XXX and it was suggested that we assist in their purchase. It was pointed out that many individuals had already donated toward the purchase. It was also noted that he will eventually need additional colors to cover the whole liturgical year, although they may be provided wherever he is assigned. It was decided to check with Kelly Dawes to see where they are at before proceeding.

4th Degree Report: Exemplification is April 19-20. It is a new presentation so please try to attend.

Good of the Order: Deacon Hector reminded all that Christ is calling you to be Holy. He also encourages us to encourage youth to consider vocations. It is sometimes lost in today's society the value and honor of becoming a Priest or religious person is as wonderful or more wonderful than becoming a Doctor or engineer.
