Business Meeting Minutes

March 11, 2009

PRIOR TO OPENING MEETING: Prior to the meeting there was a presentation by Karen Pitt and Donna Swartz, the directors of the Seton Pre-school. They talked about the Pre School and its current need for mats and equipment for their large motor skills room. The mats currently being used in the room are 8-10 years old. They expressed their appreciation for the Knights that assisted with installing their new playground equipment. They discussed the current status of the pre-school. Currently they have 84 children and operate on Wed – Friday. The school is a non profit school that strives to support itself and has indeed been self sufficient for the last several years. There are 10 Staff operating 5 classrooms. They strive to keep their budget down by looking for equipment in yard sales if possible. Their current need for mats is not driven by any code requirements so they won't have to shut down until they have them but rather they have consistently been receiving input from parents of the students attending the school that the Large motor skill room needed updating as was the area generating the most concern. The new mats estimated cost is \$1,500 dollars. The School is open to all in the community although preference is made to allow parishioners to attend whenever new openings occur. The directors were thanked for their presentation with a round of applause.

Meeting opened at: 7:45

Roll of Officers: Chaplain, Chancellor, Recorder, Financial Secretary, Treasurer and Outer Guard - Excused

Reading of the Minutes: A motion was made to approve the minutes as published by Steve Malott. The motion was seconded by Wayne Patterson. There was no discussion and the motion was called and passed.

Chaplain's Report No Report

Report on Admissions: No Report

Grand Knight's Report: The Grand Knight thanked everyone who assisted with the wives appreciation dinner. 30 wives attended and he has received lots of praise. The last fish fry was also well attended. It appears that the first two have dinners have covered our expenses and the remaining dinners will be almost all profit. The Grand Knight then reminded everyone that Knight of the year and family of the year are due this month. The dinner will be held at the Mental Memorial Golf Course on April 26th.

The Grand Knight then reminded everyone that we needed review our RSVP support for Brian O'Conner, and Ti Thompson.

Based on the program directors information we still need points for programs supporting feeding the hungry and he was open to suggestions. It was noted that the last two fish fry' took food to the food pantry and several knights also participated in the Portsmouth food project. The Grand Knight will check on whether either of these qualifies. It was also suggested that we participate in the Inter-Faith Hospitality Committee as a group to meet our requirements.

The Grand Knight then indicated that the audit was completed. He thanked all who worked on it He further expressed concern about discussions to limit our spending on charities to only those approved at the beginning of the year. The Grand Knight felt that these decisions are one of the primary purposes of Council

meetings. He broke the requests into 3 groups

1. Knights In Need - with more people losing jobs this area will probably be increasing.
2. Existing organizations we already support, and,
3. Street requests which will be presented to the council and tabled for the next monthly meeting. At the 2nd meeting it will be requested that the presenter provided information to help the council make an informed decision.

Finally the Grand Knight declared he would be holding a meeting of program chairman to create the 2009/10 budget for the coming year.

Communications: The Grand Knight read a thank you letter received for the shredder we had donated last month to Adam Noakim.

Treasurer's Report: No Report

Bills: The Bills were read.. A motion was made to forward the bills to the trustee for approval. The motion was seconded and passed.

Financial Secretary's Report: No Report

Trustee's Report: The trustee report that the Audit was good, and reminded the council that Pennies from Heaven were due this month.

Chancellor's Report: No Report

Advocate's Report: The Advocate reminded his fellow Knights that money paid to the Knights was not tax deductible. He also noted that since weather conditions did not allow a meeting last month it would be advisable to create a resolution that would allow business to be conducted through some alternate means.

Report of Service Committees/Programs:

Membership: The open house recruited one new member and put us in touch with a new transfer, Adam McClish. Gene Ebert moved to accept the transfer and Jesse Garcia 2nd the motion. The motion was passed.

It was noted that there will be 1st degrees on March 25 at St Brendan and March 12 in Lancaster. We are working on recruits but need help in recruiting additional members.

Church Director: No Report

Squires: The Squires reported that their audit was complete with the exception of the Grand Knights signature. They have been selling pop at the fish fry' but are still looking for money making fundraiser. They will be meeting with Father to discuss a can drive weekend. The 1st load would be used to support a trip to the Little League World Series for one of their members. They announced that they now have a new councilor Ed Tovar. Currently they are in the process of cleaning up their roles and they have a total of 32 members but only 20 active members. The squires are still looking for more councilors.

Respect Life: No Report

Measure Up: George is once again heading up the Measure Up campaign and has need of volunteer for April 24, 25 and May 1, and 2nd.

Charity Raffle: George Schneider has the tickets and is distributing them now. We can make \$2.40/ticket. The 1st turn in date is the 16th so please turn in any early sales by the 15th. He also suggested selling tickets at the fish fry.

Report of Standing Committee's:

Statue: The Company has identified the problem and has informed us that the manufacturer is having trouble with the statues. They have offered us our second choice statue and we have decided to accept it. Delivery is anticipated in 6-8 weeks.

Kroger Cares Program: No Report

Scholarship: We happily have 4 applications for the Scholarship this year 1 grade school and 3 high school students. Anyone considering submitting additional requests should submit them ASAP.

Unfinished Business:

Religious Ed Dinner: 12 Knights are needed to assist with the Religious Ed Dinner. TAT is catering, but volunteers are needed to man the desert table, clean silverware, clean the room afterward, bartend and man the buffet tables.

Monsignor Fairchild event: Monsignor Fairchild has informed us that his family wishes to pay for the event. The 50th anniversary celebration will Cheese, relish, mini bagels, salad and other finger food. He has requested Budweiser for 700-750 people as well. The event will be May 31st at 3:00 in the PAC. Desert will be sheet cake for the family and cookies and brownies for everyone else.

Bells for the Bell Choir: A motion was made to donate \$XXXX to the Choir for the purchase of additional bells for the hand bell choir at the last meeting and tabled. The motion was brought back to table for discussion to be voted on. Paul told the Council about the bell choir. The Bells were bough 8-9 years ago by the church. The church originally purchased 3 octaves of bells (37). Currently the bells are used by the adult bell choir and two youth bell choirs. Since their original purchase another 7 bells have been added and the choir seeks to add 5 additional bells to complete the additional octave. The additional bells will allow the use of music previously beyond the range of the current bell set. The additional 5 bells total cost is \$XXXX but \$XXXX is being supplied by other donors. The motions was called to vote and passed.

Donation for Catholic Men's Conference: A motion was made at the previous meeting to donate \$XXXX to the Catholic Men's Conference. This money is given to support the conference as it moves next year to a larger venue to support the growing attendance. New Business:

The motion was 2nd and opened for discussion. It was requested what the ad would include and it was explained that it would include congratulations to the members for the council going into the 4th degree and help support the cost of the event.

The vote was called and the motion was passed.

Field Agents Report: The Grand Knight introduced the councils new field agent stating that he had attended the entire open house. Mike discussed that only 20% of all members are insurance members and 80% are only associate members who are not taking advantage of all the options available to them. The Knights still have an AAA rating. He talked about their long term care insurance and explained how it save to purchase early. At 30 it cost \$10.40/month at 40 \$16.00/month at 70 it cost \$124.00/month and at \$80.00 273.00/month.

Respect Life: Defending Conscience Rights

The "Stop FOCA" postcard campaign at Seton and in the Columbus diocese during January was very successful. At Seton over 1800 postcards were signed and mailed. The Columbus diocese sent 40,000 postcards to its parishes. Our Congressional representatives apparently got the message, because FOCA appears to be dying in committee. Great job to everyone who participated!

Unfortunately, President Obama is still trying to live up to his promise to pass FOCA, only now it is being done piecemeal – one part at a time. One of his first acts as president was to rescind the Mexico protocol, which President Bush signed to prevent U.S. tax dollars from being sent to foreign organizations that promote or provide abortion. Next, President Obama changed Bush's stem cell regulations. Under the new rules, our tax dollars can be used for embryonic stem cell research and previously forbidden embryonic stem cell lines are now open for exploitation. For those who may not know, this means that fertilized embryos (unborn children up to a few weeks gestation) will be destroyed to harvest their stem cells.

Now President Obama has submitted a proposal to the US Department of Health and Human Services (HHS) to rescind an important federal regulation signed by President Bush. This regulation implements and enforces three federal laws protecting the conscience rights of health care providers, especially those at risk of being discriminated against because of their moral or religious objection to abortion. While the laws are already in effect (the oldest since 1973), some advocacy groups and state and local government still attack conscience rights as though they do not exist. Enforcement is also hampered by undefined terms in the laws and by failure to identify a federal office responsible for defending these conscience rights.

The regulation Obama wants to rescind clarifies the laws by defining key terms and what it means to say that providers cannot be forced to "assist" in performing objectionable procedures. It requires certain recipients of federal funds to comply with the conscience laws and gives responsibility for enforcement to HHS.

Why has the Obama Administration sought to rescind the regulation? As they did when the conscience regulation was first proposed, pro-abortion groups are again trying to flood HHS with comments attacking conscience rights. They claim the conscience clauses interfere with women's "access" to health care. These groups want to force doctors, nurses and hospitals to violate their consciences or leave the profession.

In fact, weakening conscience protection will **reduce** women's access to all health care by driving conscientious physicians and nurses out of medicine or out of the specialties (i.e. OB/GYN) where pressures to violate conscience are greatest. Many underserved areas, especially in inner cities and rural counties, would lose health care providers entirely.

We need to fight this by letting our Congressional representatives know that we support conscience rights regulation. Congressman John Fleming (R-LA), who is also a physician, is circulating a "House Member" letter to President Obama defending the health care Conscience Regulation. The letter states, in part:

"Physicians are trained to 'first do no harm.' A requirement to perform or assist in an abortion violates the most basic tenet of the medical profession. We strongly urge you to preserve the existing conscience protection rule. In the absence of guidance and education, cases of discrimination may go unchecked and professionals may continue to leave their fields, exacerbating the health care workforce crisis that is already plaguing our country. No one should be forced to participate in abortion."

CALL TO ACTION: All pro-Life Knights and their families are urged to join USCCB, Human Life International, Priests for Life, and many others in fighting this assault on human life.

It is of the utmost importance that each and every one of you tells Congress to oppose rescinding this regulation. While I am sure that he supports this regulation, we need to let Steve Austria know we are behind him, call him at 202-225-4324 as soon as possible and ask him to sign Congressman Fleming's letter!

Council Officer Duties

Gentlemen, the time has come for our election of officer's for the next fraternal year. Many ask at this time, of the duties of the positions. These are listed here below for your consideration. Those not included here ... Financial Secretary, Lecturer, and Chaplain are due to the fact that they are appointed by either the Grand Knight or Supreme.

For any of you wishing to eventually attain the position of Grand Knight, a good practice (but, not a requirement) is to hold all offices. This aids you in directing your officers once in the top spot.

Grand Knight: The Grand Knight is responsible for the welfare of the council. He presides over council meetings, acts as an ex-officio member of all committees, appoints a membership and programming director, convenes officers for a monthly meeting, and ensures all necessary reports are submitted to the state and Supreme Council. He should also be aware of the council's financial status and ensure that his signature appears on all checks drawn. The Grand Knight is a member of the Advisory Board with general supervision of the council's Columbian Squire circle.

Deputy Grand Knight: The Deputy Grand Knight is second in command. He assists the Grand Knight with council affairs and fulfills all duties assigned to him by the Grand Knight. Should the Grand Knight be absent from a council meeting, the Deputy Grand Knight presides. He is chairman of the council's retention committee and also a member of the Advisory Board charged with overseeing the council's sponsored Columbian Squires circle.

Chancellor: The Chancellor has a variety of responsibilities. Primarily, he assists the Grand Knight and the Deputy Grand Knight in the execution of their duties and oversees the council in both their absences. He is charged with strengthening the members' interests in council activities. The Chancellor is chairman of the admission committee and a member of the Columbian Squires circle ceremonial team.

Recorder: The Recorder is similar to a court reporter or a secretary. He is responsible for maintaining a true record of all actions of the council and its correspondence.

Treasurer: The Treasurer is responsible for the safekeeping and maintaining records of all council funds and accounts. He is responsible for depositing money into the council's accounts and provides a certificate of such monies to the Grand Knight. He is also responsible for payment of all expenses.

Advocate: The Advocate is the legal representative of the council and serves as the council's attorney at trials and investigations of any interest to the council. While he does not need to be a member of the legal profession, he should be familiar with the council by-laws, the Order's Charter, Constitution and Laws, Methods of Conducting a Council Meeting, and Robert's Rules of Order.

Warden: The Warden is the 'watchdog' for council property and degree paraphernalia, except the property of the financial secretary, treasurer and recorder. He is also responsible for setting up the council chambers for meetings and ceremonial work. During ceremonial exemplifications, he will appoint and supervise guards.

Inside/Outside Guards: The Guards have similar responsibilities, but distinct differences. The Outside Guard tends to the outer door admitting visitors and members to the inner door. Once at the inner door, the Inside Guard checks to make sure that their membership cards are current.

Board of Trustees: The Board of Trustees consists of three members elected by the council and the Grand Knight, who serves as chairman of the board. They oversee the work of the Financial Secretary and Treasurer, and with the Deputy Grand Knight serve on the council's retention committee. During council elections, only the Three-year Trustee is voted on, with the others moving on to become two and one-year trustees, respectively.
