Business Meeting Minutes

April 22, 2009

Prior to opening of meeting, we presented awards to the KofC 11187 Scholarship Winners (Mora and Katherine Carr, grandchildren of Ed Loch), along with Knight of the Year (Ray Creamer), Family of the Year (Patterson Family), Youth of the Year (Nick Malott), Lady of the Year (Beth Tomson), Volunteer of the Year (Mark Knight). Mora and Katherine both attended with their family and grandparents. They thanked the Knights for the scholarships and awards. Steve Malott accepted the award for his son Nick and thanked us for Nick. Ray Creamer was not present, so his award will be held. All other award winners accepted the awards and thanked the Knights with many nice words about all the good our Council does.

Meeting opened at: 7:52 pm

Roll of Officers: Chaplain, Chancellor, Treasurer, Outer Guard and 2 year Trustee - Excused.

Reading of the Minutes: Wayne Patterson moved that the minutes be accepted as published. George Schneider seconded. Motion passed.

Chaplain's Report: Hector thanked the Council for Fr. Jim for the Chaplain of the Year award. He also expressed his thanks to the Knights for all they do for Seton parish.

Report on Admissions: No report.

Communications: The Grand Knight read the following communications sent to the Council:

Thank you note from Mora and Katherine Carr for the scholarship award and money.

Thank you note from the Josephinum for the generous donation towards the purchase of athletic equipment.

Thank you note from the Bell Ringers for the donation towards the purchase of new bells.

Grand Knight's Report: No report.

Treasurer's Report: Report to be given by Grand Knight in absence of Treasurer

Financial Secretary's Report: Mark read the deposits and bills.

Mark reported that 23 members are past due on dues. He has turned the list over to the trustees, who will contact the members.

Trustee's Report: Mike reported that nominations for next year's officers are nearly complete, with only a couple of open spots remaining.

Chancellor's Report: No report.

Advocate's Report: No report.

Report of Service Committees/Programs:

Membership: Mark read an article about Capt. Phillips, the Captain of the US destroyer that rescued the merchant marine Captain from Somali pirates. Capt. Phillips is a 4th degree Knight of Columbus and is the kind of hero we want to recruit for our council. We need three new members installed by the end of June to make Star council, so get busy recruiting. Any

Knight involved with RCIA should talk to the new men about joining the Knights. There will be a 2nd/3rd degree at St. Andrews this weekend.

Program Director: All of our reports have been submitted and we have enough points to make star council, but we need 3 new members before the end of the council year. We have enough insurance members also.

Church Director: No report.

Squires: The Squires made over \$XXX selling pop at the fish fry's, which is about double what they made last year. They led the state in matching funds for the 2nd year in a row. They did not get permission from Fr. Jim to put an aluminum recycling bin on church property, so they are limited in what they can do to raise money this way.

Respect Life: The Respect Life committee will be potting flowers in cups decorated by Religious Ed students and will take them to a nursing home in early May. Check the bulletin for details. Edd gave the Grand Knight a copy of a letter to Barb Serrano (SPY youth director) confirming 15 spaces to spend the night at the Basilica of the Immaculate Conception in Washington for next year's March for Life. With the 18 Seton parishioners who went this year, we already can fill over half a bus - we would need only 7 additional people to reach the 40 person minimum required by the council. Edd suggested we sponsor a bus again in 2010.

Report of Standing Committee's:

Charity Raffle: 355 tickets have been turned in for \$XXXX. He will be putting additional tickets in Knights' mailboxes.

Measure Up: (George Williams) The funds raised through the Measure Up campaign help people with mental disabilities by supporting Fairfield Industries and Pickerington Special Olympics. The Special Olympics primarily help children while Fairfield Industries primarily help adults. George still needs volunteers for May 1-2, so please call him to help in this worthy cause.

Statue: No report.

Kroger Cares Program: Kroger's is discontinuing the present Kroger's Cares program in May and will be replacing it with a new program. We have already received the funds from cards purchased previously, but will receive nothing if they are recharged after April. In the new program, you register your Kroger Plus card on a website and we will receive a share of \$1,250,000. Kroger will divide the money between all participants based on certain limitations like a maximum of \$300 per person. Most purchases will count, but not fuel, liquor, etc. Terry will let us know more next meeting.

Development Committee Magnet Sales: The people who were running the program in Illinois have turned the reins over to a new group. The new people are getting up to speed. They are pushing decals this year. They expect to surpass the 1 million magnets sold point this year.

Unfinished Business:

Hand Bell Choir: Paul demonstrated the bells recently purchased with help of our council. He also showed us their

Fr. Fairchild 50th Anniversary: Fr. Fairchild will be celebrating 50 years since ordination with a Mass at Seton on May 31. Our council will serve a cold cut style dinner afterward. Wayne needs help, so call if you can help serve.

First Communion: Wayne still needs help for First Communion this Saturday at both the 9:30 and 1:00 Masses. Please call him if you are a Eucharistic Minister or if you can come in 4th Degree regalia.

New Business:

RSVP: Frank asked for a motion to donate to Seminarians Brian O'Connor and Ty Tomson. George Williams moved that we donate \$XXX to Brian, seconded by Steve Malott. Motion passed. Terry Reine moved that we donate \$XXX to Ty, seconded by Jesus Garcia. It was pointed out that Ty is no longer a member at Seton, but his mother, Beth, is the parish secretary. Motion passed.

State K of C Convention: Frank asked for volunteers to be delegates at the state convention in Cincinnati May 22-24 (Memorial Day weekend). The council will pay the expenses for the delegates. Two delegates are needed. The convention will be held in the Millennium Hotel and rooms are \$89/night. A couple of people are interested, but must check with wives first. They will let Frank know.

Pregnancy Decision Heath Center: Frank asked for a motion to donate to support PDHC. This is a worthy cause we have supported in the past. PDHC does a lot to fight abortion in a practical way by offering pregnant women ultrasounds, prenatal care, and post partum care. During Lent the parish had a Pac-N-Play in the gathering space and Wayne Patterson reported that he took 26-27 boxes of baby items to PDHC. Jerry Lowery moved that we donate \$XXX to the Fairfield County PDHC. Terry Reine seconded and the motion passed.

Seton Parish Preschool: Frank asked for a motion to donate to the preschool for activity mats. The mats they need cost \$1500. After some discussion, we decided we don't know if they are receiving donations from other sources, so we should not donate the entire \$XXXX. Steve Malott moved that we donate \$XXXX to purchase the mats. George Yurt seconded. The motion was tabled until the next meeting to comply with council rules due to the amount.

Respect Life: Free Speech and Parental Rights

Three recent actions show that even though FOCA is likely dead, the Obama administration is continuing its assault on the Culture of Life and free speech. A Homeland Security report defines opposition to abortion as a terrorist act:

April 15, 2009: A new Barack Obama administration Homeland Security report states that those of us who oppose the holocaust of abortion are "hate oriented" with the implication that we are terrorists.

In part, the report states: "Rightwing extremism in the United States can be broadly divided into those groups, movements, and adherents that are primarily hate-oriented (based on hatred of particular religious, racial or ethnic groups), and those that are mainly antigovernment, rejecting federal authority in favor of state or local authority, or rejecting government authority entirely. It may include groups and individuals that are dedicated to a single issue, such as opposition to abortion or immigration."

This is a fear pressure attempt to silence free speech and stifle good work to help women and save unborn babies from death.

Along those same lines, even speaking out against abortion could be considered a crime if this new bill passes:

H.R. 1913, the "Local Law Enforcement Hate Crimes Prevention Act of 2009," will likely be brought before the full House of Representatives today or early next week.

This dangerous legislation, which may form a legal basis to criminalize even a sermon or Bible reading as "hate speech," resulting in potential fines or even imprisonment of pastors, Sunday school teachers, youth leaders, Christian counselors, and religious broadcasters. Speaking out against abortion in any way would be a crime according to this law.

The word 'intimidation' in H.R. 1913 is so broadly defined that no American is safe from this threat. **Certainly prayer at abortion mills, quiet and peaceful as it may be, would be considered criminal under this law.**

The so-called hate crimes bill will be used to lay the legal foundation and framework to investigate, prosecute and persecute pastors, business owners, Bible teachers, Sunday School teachers, youth leaders, Christian counselors, religious broadcasters and anyone else whose actions are based upon and reflect the truths found in the Bible.

H.R. 1913 broadly defines "intimidation". A pastor's sermon could be considered "hate speech" under this legislation if heard by an individual who then acts aggressively against someone. The pastor could be prosecuted for "conspiracy to commit a hate crime."

During Committee markup in 2007, Rep. Arthur Davis (D-AL) admitted that the legislation will not protect a pastor from prosecution.

Meanwhile, the FDA is undermining parental rights:

April 22, 2009: News has just been released that the FDA will soon announce that it is complying with a federal judge's order to overturn a Bush administration policy and **permit 16-year-olds to obtain the "Morning After Pill" (Plan B) birth control pill without a prescription.**

The FDA will later evaluate whether all age restrictions will be lifted.

NOTE: A girl under 18 cannot even get her ears pierced without a parent or guardian present and signing a release, yet she can obtain this mega dose of hormones that sometimes acts as an abortifacient with no parental or physician supervision.

This last issue is especially disturbing, particularly if you have daughters, because the long term effects of these pills have not been studied and there are serious risks with their use. These include heavy bleeding, infertility, and even death, but you can bet your underage daughters will not be informed of these risks or other side effects. Few young girls would think to ask about risks, but parents almost certainly would. This is just part of an ongoing liberal campaign to promote sex without consequences.

You can do nothing and let our rights be eroded by those who want to impose their warped values on the rest of us, or you can take action:

Write to President Obama to tell him you oppose these actions. Ask him to respect our right to free speech, freedom of assembly and even in opposition to the abortion he so adamantly supports.

Call Steve Austria at 202-225-4324 as soon as possible and ask him to oppose H.R. 1913 and the FDA ruling.

Insurance Corner - May

Why Become an Insurance Member?

The laws and rules of our Order, as well as state (provincial) laws, specify that the Knights of Columbus may accept insurance applications from members only. As a member, you may apply for insurance on **YOURSELF**, your **WIFE** and your **MINOR CHILDREN**.

The Order's Board of Directors has taken action, though, to assure that a Knight's widow maintains the right to purchase additional insurance for a limited time. This can be of great benefit and comfort to those we leave behind.

This "right to apply" is available only to the widows of insured members. If a member has not availed himself of our highly rated life insurance program, or purchased an annuity or long-term care policy, this benefit is not available to his widow.

But if the member was an insured member, his widow has the right to apply for additional insurance on her life and on the life of the member's minor children. This right must be exercised within one year following the Order's receipt of proof of the insured's death.

Know two things. First, I'll assist your widow and children in any way possible if you should die, both with your Knights of Columbus insurance and any other life insurance you may have. Second, I'll provide them my best professional advice and service, to assure that they have adequate insurance protection. I am here to answer any questions and never hesitate to call or email me when these questions come to you. I am here to service all Knights whether you have insurance, an annuity, or long term care. Remember, it only takes you doing one of our three highly rated programs to become an insurance member!

I have no greater responsibility.

Council Officer Duties

Gentlemen, the time has come for our election of officer's for the next fraternal year. Many ask at this time, of the duties of the positions. These are listed here below for your consideration. Those not included here ... Financial Secretary, Lecturer, and Chaplain are due to the fact that they are appointed by either the Grand Knight or Supreme.

For any of you wishing to eventually attain the position of Grand Knight, a good practice (but, not a requirement) is to hold all offices. This aids you in directing your officers once in the top spot.

Grand Knight: The Grand Knight is responsible for the welfare of the council. He presides over council meetings, acts as an ex-officio member of all committees, appoints a membership and programming director, convenes officers for a monthly meeting, and ensures all necessary reports are submitted to the state and Supreme Council. He should also be aware of the council's financial status and ensure that his signature appears on all checks drawn. The Grand Knight is a member of the Advisory Board with general supervision of the council's Columbian Squire circle.

Deputy Grand Knight: The Deputy Grand Knight is second in command. He assists the Grand Knight with council affairs and fulfills all duties assigned to him by the Grand Knight. Should the Grand Knight be absent from a council meeting, the Deputy Grand Knight presides. He is chairman of the council's retention committee and also a member of the Advisory Board charged with overseeing the council's sponsored Columbian Squires circle.

Chancellor: The Chancellor has a variety of responsibilities. Primarily, he assists the Grand Knight and the Deputy Grand Knight in the execution of their duties and oversees the council in both their absences. He is charged with strengthening the members' interests in council activities. The Chancellor is chairman of the admission committee and a member of the Columbian Squires circle ceremonial team.

Recorder: The Recorder is similar to a court reporter or a secretary. He is responsible for maintaining a true record of all actions of the council and its correspondence.

Treasurer: The Treasurer is responsible for the safekeeping and maintaining records of all council funds and accounts. He is responsible for depositing money into the council's accounts and provides a certificate of such monies to the Grand Knight. He is also responsible for payment of all expenses.

Advocate: The Advocate is the legal representative of the council and serves as the council's attorney at trials and investigations of any interest to the council. While he does not need to be a member of the legal profession, he should be familiar with the council by-laws, the Order's Charter, Constitution and Laws, Methods of Conducting a Council Meeting, and Robert's Rules of Order.

Warden: The Warden is the 'watchdog' for council property and degree paraphernalia, except the property of the financial secretary, treasurer and recorder. He is also responsible for setting up the council chambers for meetings and ceremonial work. During ceremonial exemplifications, he will appoint and supervise guards.

Inside/Outside Guards: The Guards have similar responsibilities, but distinct differences. The Outside Guard tends to the outer door admitting visitors and members to the inner door. Once at the inner door, the Inside Guard checks to make sure that their membership cards are current.

Board of Trustees: The Board of Trustees consists of three members elected by the council and the Grand Knight, who serves as chairman of the board. They oversee the work of the Financial Secretary and Treasurer, and with the Deputy Grand Knight serve on the council's retention committee. During council elections, only the Three-year Trustee is voted on, with the others moving on to become two and one-year trustees, respectively.

If you have any questions, please contact any of the current officers.

Office Nominations

Here is the candidate slate for next year's officers. All except those appointed by the Grand Knight or Supreme are open for nomination and election, as long as his dues are paid.
